- Functional Curriculum for Children with Communication Disorder.
- Vocational Training avenues for adults with Communication Disorder.
- Discourse analysis of adults with language disorders: use of perceptual scales and software.
- Product outcomes-in terms of advanced assessment tools, indigenous software tools for assessment and management
- Evidence based research
- Application of advanced technology in speech-language therapy services
- Development of students learning modules for clinical practice
- Development of indigenous products.

Further, the researchers who have been sanctioned ARF projects previously are hereby informed to

- Indicate the status of completion of ARF project sanctioned to them during the previous five year in the prescribed format titled Format for Research proposal (download from www.aiishmysore.in) under Research
- Indicate the timeline in quarterly interval

- Indicate the progress made in the ARF project sanctioned to them during the year 2022-23 by mentioning the milestone achieved (publication, seminar, conference and symposium presentation, product development).
- The PI(s) / CI (s) can involve only in maximum of two projects as either PI/CI during the current year including any pending project sanctioned during the previous years. If any staff at AIISH or applying Institute is already having two sanctioned and on-going projects under the same scheme will not be permitted to apply for another research Proposal under the same grants. Further, the competent authority may permit to consider the third proposal of the investigator with a track record of timely submission of quarterly reports, final report and outstanding achievements (in terms of publication).
- The role of PI(s) and CI(s) should be delineated and specified for each project signed by PI and CI respectively, while forwarding the hard copy and soft copy of the proposal.
- Research Proposal can be from any Speech and Hearing Institute/organisation but the Principal Investigator must be from AIISH and Co-PI can be from the other institute.
- The Research Officer recruited under the sanctioned project has to mandatorily work at AIISH at least for the 50% of the duration of the project.
